Every entry shall constitute an agreement that all participants which include without limitation, the owner, lessee, trainer, manager, agent, coach, rider, handler and the horse, for themselves, their principles, representatives, employees and agents: 1) shall be subject to the constitution and rules of the USEF Federation and the local rules of the competition; 2) represents that every rider, and handler is eligible as entered; 3) agree to be bound by the competition and rules of USEF and OCIEL and will accept as final the decision of the hearing committee on any question arising under said rules and agree to hold OCIEL and USEF, their officials, directors and employees harmless for any action taken; 4) agree that they participate voluntarily in the competition fully aware that horse sports and the competition involves inherent dangerous risk of serious injury or death and by participating they expressly assume any and all risk of injury or loss and agree to indemnify themselves and not hold USEF, OCIEL, their school, the competition and their officials, directors employees and agents harmless from all claims including for any injury or loss suffered during or in connection with the competition whether or not such claim, injury or loss resulted directly or indirectly from negligent acts or omissions of said. It is hereby understood and agreed that the OCIEL, its officers, directors employees, owners, representatives and agents are named as additional insureds.

I agree to indemnify and save harmless OCIEL, its show and directors, the facility and all directors, officers, members, employees and agents, and participating schools herein from and against any and all loss, cost or expense of any claim thereof whatever nature arising or arise for and on account, or any reason of entry or entries hereby made.
